Tätigkeitsprofil und Auftrag:

Die neue Servicestelle für Ethik, Wissenschaft und Konfliktmanagement der INF-FNI bietet Mitgliedern aller Föderationen Unterstützung in Fragen ethischer, wissenschaftlicher und psychosozialer Natur, gelegentlich auch zur Klärung interner Konflikte.

Der/die Repräsentant/in ist als professionelle/r Ansprechpartner/in und Schlichtungsbeauftragte/r eingesetzt und arbeitet mit dem Komitee (Präsident/in, Vizepräsidenten und Rechtsrat*) zusammen.

Die Servicestelle bildet die Basis zur Vernetzung bei Naturismusbezogenen externen oder internen Problemen. Anlassbezogen wie grundsätzlich können ethische, rechtliche und psychosoziale Problemstellungen erläutert und adäquate Reaktionsweisen erarbeitet werden. Eingehende Vorschläge werden in dem Büro gesammelt. Hernach werden, konsensual, Lösungsvorschläge erarbeitet. Diese werden nach Beschlussfassung in die Sprachen der INF-FNI übersetzt und innerhalb der Föderationen veröffentlicht, gelegentlich auch als Stellungnahmen der INF-FNI und Diskussionen ausgewählten Medien zur Information und Diskussion angeboten.

Sohin können alle Ergebnisse quasi „weltweit“ genutzt werden. Sowohl die je nationale Gesetzgebung als auch Rahmenbedingungen, Kultur und Glaubensfragen sind zu berücksichtigen und innerhalb der betreffenden Föderation auf Basis bestehender Regularien der INF-FNI im Sinne des Naturismus umzusetzen.

Activity Profile and Mission:

The new service of “Ethics, Science and Conflict Management” within the INF-FNI Committee has been created as a point of contact and service for members of all federations in cases of any ethical, scientific, and psychosocial issues, or for the clarification and settlement of occasional internal conflicts.

The assigned Representative acts as a professional contact partner and “clearing agent” within the committee, in a close cooperation with the President, the Vice Presidents and the Law Council*).

The ECM Office has been created as a legal basis for any casuistic networking, no matter if corresponding to external attacks or dealing with any internal disagreement. Ethical, legal or psychosocial issues, no matter if case-related or of a fundamental nature, will be consensually clarified, and adequate reaction will be suggested to the applicants. Incoming suggestions will be collected, then the Representative will thoroughly collaborate in favour of adequate solutions, which shall be decided, subsequently translated into the official INF-FNI-languages, and published for any corresponding application. Public discussions in the media will be an option.

This will make the results, more or less, globally applicable. Any national legislation and corresponding “framework conditions”, such as religious or ethical concepts, are meant to be coordinated with the INF-FNI federative rules and regulations, all in accordance with the fundamental ideals of Naturism.

Perfil de trabajo y tarea:

El nuevo centro de contacto y de servicio para la ética, ciencia y la gestión de conflictos de la INF-FNI ofrece a los miembros de todas las federaciones apoyo con preguntas de carácter ético, constitucional, científico y psicosocial, a veces también para aclarar conflictos internos.

El o la representante está instalado/a como persona de contacto profesional y como mediador/a y colabora con el comité (presidente, vice presidente y asesoría jurídica).

El centro de servicio constituye la base para el entrelazamiento en problemas relacionadas al naturismo externos o internos. Problemas de carácter ético, jurídico y psicosocial pueden ser explicados y se pueden desarrollar patrones de respuesta adecuados, tanto en ocasiones específicas como de manera general. Propuestas entrantes se recogen en la oficina. Púés se elaboran, por consenso, propuestas de solución que se traducen después de la resolución a los idiomas de la INF-FNI y se publican en las federaciones. De vez en cuando se ofrecen también como opiniones de la INF-FNI y para discusiones de medios seleccionados para informar y discutir. Por lo tanto, todos los resultados pueden ser utilizados prácticamente "en todo el mundo".

Hay que tomar en cuenta tanto la legislación nacional como las condiciones básicas, y cuestiones de cultura y religión y aplicar en el sentido del naturismo dentro de la respectiva federación sobre la base de las regulaciones existentes de la INF-FNI.

1st Constitution of the Team on December 19th, 2017 (agreed again on April 17th, 2018):

- 1.1. Official nomination of new Fellows by Volkmar,
following his CC mandate of November 3rd, 2017
- 1.2. Exchange of information on individual skills and priorities, both, orally and by papers
- 1.3. Agreement on details
 - 1.3.1. English declared the official language
 - 1.3.2. Informal co-operation, based on the exchange of E-Mails (official mail-accounts to be provided by the CC) or (if essential) by personal meetings, in either BER, VIE or other
 - 1.3.3. The “Six-eye-principle”: One Fellow – one vote: the principle of full accord – in cases of dissent following Thomas Gordon’s model of conflict solution. – For any scientific clarification beyond own expertise, external scientists may be involved, in order to achieve a fundamental orientation prior to a finding.

2nd Order of official reactions on appeals:

- 2.1. Appeals to be collected by the Bureau for Ethics, Science and Conflict Management
- 2.2. Translation, if necessary, and distribution of the contents to the Fellows – by Volkmar
- 2.3. Evaluation of contents by the respective Fellows
- 2.4. Exchange of papers between all Fellows in order to be studied and annotated
- 2.5. Discussion on a possible reaction:
 - Comment (e.g. on the competence of the ETC, regarding the content of issue risen)
 - Networking in order to enable suitable solutions on the respective level,
local, regional / within a federation, or global
 - Finding (either binding or as a recommendation)
- 2.6. Agreement on the final paper
- 2.7. Distribution of the finalized reaction by Volkmar – to:
 - 2.7.1. the appellant(s), if other than an ETC’s initiative
 - 2.7.2. the INF-FNI Central Committee
 - 2.7.3. the ETC Fellows for documentation
 - 2.7.4. the biannual INF-FNI Congress, in an adequate summary

3rd The ETC’s initiatives:

Without an appellation issued, it is the ETC’s competence to rise issues and find normative solutions to fundamental questions concerning the ethical, scientific, philosophical, medical, psychological or intercultural (semantic/semiotic, behavioral, religious, environmental) aspects of naturism. **On focus will be the preservation and defence of Naturism in any environment, be it physical (like on beaches or inside facilities) or mental – that is, as a certain attitude towards life and nature.** The team came to the conclusion, *ETHICS* – seen as a fundamentally *philosophical position* and *argumentative tool* – can become relevant in certain political, moral, scientific, or legislative discussions. Taking in consideration that naturism, as an organized movement, is being considered more or less obsolete in times of hedonism, egocentrism and “laissez-faire”, at the same time being contradicted, ignored or restricted by political and mental dictatorship of self-defined potentates, “leaders”, pseudomorph–democratic or religious movements, ***all of us have to take wise action.***

These surroundings and some conflicts given, the Ethics Council will offer fundamental references and findings, and is ready to offer mediation to all members and INF-FNI institutions, on demand.

4th General matter for a common consent:

The Ethics Council ETC is not interfering with situations given, but can offer sound, and fundamental, arguments – or official findings on demand.

The ETC is an independent unit. It will, on appeal or on its own, offer acceptable information and even solutions for specific problems based on experts opinions. In its independency lies its power. In critical situations, that may become valuable.

Arnold (oral remarks at the constitutional meeting, Dec. 19th, 2017):

Naturism is not a lifestyle, it has been the origin of organized life in groups, even in historic times. People in Northern and Central Europe, were not dressed, except for carpets of fur, but rather used fire to fight the cold climate and survive. This could be seen e.g. in Terra del Fuego (South America).

As Arnold has been studying indigenous peoples for nearly two centuries, his findings are remarkable: Not only could he detect tendencies of urbanized people, to follow the market’s principles by engaging others in their “buying-and-selling” resp. “growth” philosophy.

Other tribes, living naked, would be mentally pressurized by being called “monkeys” by those who had, before, been tempted (seduced) to join the chains of micro-capitalism. So, in an example, he met naked living people extensively dressed up, as long as he and his students were in company of “urbanized” people of their own. As soon as they had been out of sight, the “non-urbanized” people would take off their clothes, with relief, as Arnold and his students offered to be naked, as found and agreed natural. This will rise a methodological issue: Can any behaviour – be it, to arrive dressed, or get undressed in expectation of an undressed society – make the respective society change their habits?

Ethics, in such a case, would reflect the theory of any proper scientific access towards cultures other than the own.

For “industrialized” countries or any other cultures that do not lead or accept a naked living, the mere possibility of individuals and groups who try to find “back” to a “natural” life, might be an obstacle and stressor to the beliefs or traditions of a majority. Like that, naturists in a non-naturist environment will be detected and focussed as a counterpart, if not an enemy.

That would tend towards a situation similarly seen in the relationship towards *indigenous peoples*^{*)}. How could members of the respective federations act in order to approve their awareness?

The Ethics Council, being created as a commission within the INF-FNI, could become a think-tank for adequate public statements, discussions and movements, in order to protect naturism, in any environment, worldwide.

In a written comment (by December 27th, 2017 – literally quoted):

What we call Naturism today has been normal in ancient times. Public nudity was common in ancient Rome, Greece, Egypt etc. As for Europe, it is known that people like the Celts were naked in everyday life. Even in the harsh climate of Tierra del Fuego (between South America and the Antarctic), the indigenous peoples only used to have some fur on their shoulders occasionally, and to warm up by the open fire. When the Europeans introduced clothes, these peoples were soon extinct. Public nudity was normal in summer in Scandinavia in the 1920s, as I know from my father's child memories.

I have been studying indigenous peoples since the 1980s. In our excursions I found that they often dress up for visitors, but when they are among themselves, they are partly or even fully naked. This can be found out when the research team takes off clothing themselves. When we were body painted, without any clothes on, by the Emberá in Panama, the indigenous artist told us that they always painted each other's whole body.

*As representatives of the “global” culture, we can use the existing dominance to bring back the nudity to indigenous peoples, from whom it has been taken away by our culture. This is actually our obligation, as Article 11 of the **UN Declaration on the Rights of Indigenous Peoples** grants their right to revitalise their culture.*

I urgently suggested that naturist organisations of countries with indigenous peoples cooperate with the latter.

Finally, an issue we have in Berlin is that of fully dressed Americans, who sketch naturists at the Wannsee beach. If they would join us as naturists, that would be alright, but otherwise we feel exposed like zoo animals (or like indigenous people watched by fully dressed visitors).

Volkmar (summary, Dec. 19th, 2017):

Comparable matter may be issued in the future. Members are called to find fundamental problems or exemplary situations like the one above, and bring these in.

The Ethics Council, ETC, has been established a few months prior to the 65th anniversary of the INF-FNI as an international organization, 1958 – 2018. As an idea, it has been developed from the basis of a new “Bureau for Ethics, Science and Conflict management”, BECM, aiming to service all members and federations in any questions, topics or issues of fundamental, philosophical, or relational origin.

The “Bureau” is using the existing infra-structure of Volkmar’s office (<http://medpsych.at>, founded in 1989). It may be addressed by letter, phone or e-mail (see below).

Appeals and the discussion of ideas (either scientific, conflict- or event-related) is free of charge to INF-FNI members and member organizations, as long as Volkmar, at the same time, is member of the Central Committee. Only travel expenses have to be re-imbursed, so far.

The Ethics Council had to be designed to complete the “Bureau” with respect to more fundamental tasks, as any standard work has to be achieved by more than one expert.

ETHICS, in a common understanding, is being considered fundamental.

Therefore, individuals could be invited to become Fellows through a democratic process, whereas their findings, on a scientific level, may not be submitted to a majority’s votes.

In the Lisboa CC meeting, November 2017, Volkmar was authorized to – by global invitation – find honourable naturists, in order to form a group of experts who could work on related issues.

The ETC, Ethics Council, has been established as a commission within the INF-FNI, head of the ETC being Volkmar, as a CC member. The new entity will have to be confirmed by the Congress.

Major interest of the ETC is the protection of naturism, and in cooperation with the CC, the federations and all interested INF-FNI members, the development of “naturism” as a fully accepted pattern of living (other than a “life-style”).

Filipa (additional address – May 15th, 2018):

I am not an academic researcher on issues of ethics and naturism. I am an anthropologist, a woman, and I am a naturist. I believe that, being a naturist, practising naturism is a human right, as simple as it is a right to be granted education, health, equality...

As an anthropologist, I watch and even assimilate differences that presumably exist in human societies. Still the origin is the same. Some societies move away from their purest state, in search for development and technological growth – which, however, is threatened to be segregated from our roots in communion with nature.

I agree with “Naturism is a practice as old as all species”. – I myself may say, we are born naturists: The human species in its genesis is naturist, in the true sense of the word. Naturism is the “human condition”, *conditio humana*, in its relationship with nature, and among social groups.

Because I believe naturism is a human right, I am available to appeal for respect. I think this will be seen as a basis of any ethical discussion: **Respect**.

... respect for ethical principles, which merge with humanistic and naturist values, still opening up to the whole community.

In co-operation with my Fellows, I stand for mutual respect between fellow humans and for nature.

It is necessary not to forget that all humans are born free and equal. Naturism reminds us: This is how we could continue to thrive, for a lifetime. We need not ask for permission.

Ethics – independent positions and arguments - will be a fundamental support to the protection and defense of naturism, with respect for the differences that characterize human nature. “There is a right to live Naturism.”
