Dear Mrs. Pelosi,

may I send you an external feedback on the Trump crisis:

1<sup>st</sup> Mr Trump has – for decades – shown clear symptoms of a so-called **histrionic disorder F 60.4** (narcissism F 60.8).

Taking in consideration what we know about his direct ancestors, we may understand an unsolved parental conflict that drives him to an extremely egocentric and dominant behaviour, at all possible costs

2<sup>nd</sup> That leads to a pathway not allowing any sign of failure

- 3<sup>rd</sup> Driven by a decision to never fail – therefore be superior even to his father – his lack of empathy is associated with the creation of “alternative truth” in all cases of dooming discrepancy between facts and illusion
- 4<sup>th</sup> Trump’s career is showing dramatic failures, which led to even deeper conflicts with reality
- 5<sup>th</sup> Trump is, therefore, a victim of his never solved conflict of the early childhood, which not only allows, demands one result: either a fantastic career or the complete destruction. Once, his self-description was: *Wrecking ball*.

Many people worldwide sympathize with histrionic patients, as these happen to seem both, authentic, and offering a blank screen to the masses for a sufficient projection of their own deprivation. Individuals then tend to sacrifice parts of their self in order to merge with the leading group in an “erotic” identification with a *Fuehrer* (in: S. Freud: *Group Psychology And the Analysis Of the Ego*, 1922).

Hence, it was understandable, but has become highly risky to have a man, driven by destructive concepts, act as, and minister wide ranging rights and power of, a President:

As he obviously has no other choice than becoming as mighty and invulnerable as ever possible, he will become ultimately destructive at any stage of his dooming final combat.

One may call such a person mean, unreliable: That will derail the argument from the factual to an emotional or even moral assessment and category.

POTUS' actual situation is highly vulnerable, as having received rather unique and risky a medication, consisting of

1<sup>st</sup> **monoclonal antibodies:**

These are known as highly effective, e.g. in a praeterminal condition: someone else's antibodies take over the work of a patient's lacking own antibodies

2<sup>nd</sup> **corticosteroids:**

They regulate down inflammatory processes with the risk of as well decreasing a patient's immune response (which may become dangerous for any long term application). Steroids have **no effect on viral activity**, whatsoever. They could mask existing severe symptoms. They are also known for their **psychomodulatory side effects**, resulting in euphoric or manic phases, together with a partial loss of the sense for reality

3<sup>rd</sup> **Remdesivir**, an anti-viral pharmacon, not in particular valid against CoVi-19, still good for hopes.

Taking in consideration, he had got this 3 part cocktail from the first day / the first expression of symptoms, Mr Trump is the world's one and only patient to recover even before the end of first treatment. In an euphoric state of mind he calls the disease a "blessing", which sounds quite cynical. This will further contribute to his self-assessment (and that of his followers) as a superhuman.

Together with his general loss of sense of reality, that may have driven him to the known recent statements, as well

as to decisions e.g. stopping negotiations on further crisis protection measures.

His excessively brilliant mind tells him and the globe: I could, so everyone else can, recover – from all you want, if only you behave bravely enough. Everyone can, if only following my example, defeat the virus by merely ignoring its capacities, and so fight that kind of infection. As a result, people had better show up for work and support economy than behaving like frightful children.

People are meant to vote for him as a SALVATOR MUNDI – in case they refuse, severe punishment will be in place.

His language shows elements like in 1 Kor. 15, 50 f., which are at the same time conclusive, and Bible Speech – still in the mouth of a false prophet, indeed.

On the very peak of his poor existence, Mr Trump, the POTUS, obviously is not capable to surrender to a negative election result. “Stand by” then means, “get my enemies, these *monstrous Communists*, out of the way, and let me run for the Peace Nobel Prize (for a third time)”. His weapons are mockery, scorn, and disparagement. In his present condition of being unable to accept reality, he will – in case of what he might fear as his ultimate failure – take his own disciples, followers, the United States, the world with him.

Histrionic disorders are known for their compellingly destructive final outcome: With POTUS, this outcome will be disastrous to himself and society; it must be stopped *ex ovo* – prior to its emergence – **by all legal means**.

Possible counter-arguments will have to be addressed to the public rather than this individual.

One among them is:

Mr President has received a unique treatment from the very first moment on, probably he did not even think of anybody else, not even his present wife, the FLOTUS.

He will never agree to be considered a **spreader** himself, reality will, therefore, certainly be misinterpreted in a way that makes him the **first victim** with a glorious recovery.

As long as that kind of highly risky treatment will neither be recommendable nor available to every single citizen, one is wrong to insinuate everyone might recover as quickly as himself.

POTUS has shown no empathy, nor does he seem to feel responsible: for the 212.000 victims, or 7.55 million average people having to deal with their infection, loss of work and home. Naming Trump a Life Saver, as Mr. Pence did, bears extreme cynism, a complete lack of factual speech.

Driving them to the erroneous conclusion, CoVi-D-19 might be an easily manageable disease, will lead to the fatal conclusion:

Only the Weak will die.

(Let them perish for the sake of an even smarter Trump-USA.)

I am now convinced, Mr. Trump has no correct understanding at all on medical implications or his own luck, he has, most certainly, not at all learned from the event:

Others have nourished his own illusions, instead, still frightened to be dismissed (“fired”).

Therefore, this man needs to be protected from his own destructiveness, at the same time, Society deserves to be protected from his destructiveness, no matter, if (or if not) significant parts might tend to identify with him in a critical mental and social situation of their own.

A president incapable of fulfilling his functions due to a mental and physical disorder must be stopped from doing so.

Democracy and society are at stake, with global implications. The persistent use of lies, rude language and reckless strategies as an outcome of an extremely dominant attitude has already had most destructive an impact on the behavioural patterns of infants and minors, parents and: decision makers worldwide, which can be detrimental to future societies, thus must be terminated as soon a possible.
